

Consultation on the Admissions Policy and a change to the Published Admission Number of St Paul's CofE Primary School, Newcastle upon Tyne.

Love God Serve the Community An Excellent Education We are consulting on our admissions policy for 2025 onwards.

The admissions policy is in line with the School Admissions Code 2021.

The significant changes are:

- Reduction of the PAN (35 to 30)
- Changes to the oversubscription criteria (simplified see the admissions policy)
- Increase in Nursery places from 2025 (21 to 26)

The governors invite you to take part in a consultation about a proposal to reduce the Published Admission Number (PAN) for Reception admission at St Paul's CofE Primary School from 35 to 30, with effect from September 2025.

For children already in the school, there will be no change and year groups that exceed 30 children will be managed appropriately as they progress through the school to Year 6. The proposed change will not affect pupils who choose to accept an offer for a school place in September 2024.

Published Admission Number (PAN)

The PAN is the number of places we make available as part of our normal Reception intake. Once the PAN has been set for a school, we will not refuse applications submitted during the normal admission round for Reception where the PAN has not been exceeded.

Why we propose the change

We currently have a PAN of 35 which is unusual for a primary school.

As class sizes are capped at 30 for Key Stage 1 classes, this means we must run three classes for up to 70 students in Key Stage 1.

It also provides the added complication of how to teach mixed age group classes.

This year we have set out a 2 year rolling programme to ensure we deliver the full national curriculum. Previously we have had to teach to classes of 35 in Key Stage 2.

Our children do receive a broad, balanced and engaging curriculum.

Reducing the PAN will allow us to use the classroom space more effectively.

We have sought advice from education experts on how to make a PAN of 35 work.

Educational experts (Local Authority, Diocese, Headteachers, Curriculum designers) recommend we reduce our PAN to 30.

Proposed PAN change for 2025-26

The governors have agreed that they would like to make this change.

The change would bring us in line with other primary schools in the Local Authority who have an intake of 30.

This reduction in PAN will not affect the ethos, values and current success of the school. It will ensure that the quality of education and the available facilities are further improved.
