Guidance notes:

- This form is to be used for an application for a grant (or to request a change of name) of a unlicensed family entertainment centre gaming machine permit under the Gambling Act 2005 Section 247 and Schedule 10.
- 2. An unlicensed family entertainment centre is entitled to provide an unlimited number of category D gaming machines available for use on the premises. Category D gaming machines are defined in The Categories of Gaming Machine Regulations 2007 Statutory Instrument 2158 of 2007. Category C (adult) gaming machines CANNOT be made available for use and thus there will be no 'designated adult areas' required at the premises.
- 3. The permit's duration is 10 years. A renewal application must be made 2-6 months before the expiry date of the permit (Schedule 10 paragraph 18 Gambling Act 2005).
- 4. The fee for a new application for grant is £300. The fee for a change of name is £25.
- 5. Applicants should be aware that this Licensing Authority has published a 'Statement of Principles' under Schedule 10 paragraph of the Gambling Act 2005. The Statement of Principles is available via this authority's website or via a request made to the contact details provided at the top of this form.
- 6. This licensing authority must notify the applicant of its grant / refusal of the application for a permit as soon as is reasonably practicable after that decision to grant / refuse has been made.
- 7. These permits cannot be transferred. Change of name is only permitted where the permit holder changes his / her name or wishes to be known by another name (Schedule 10 paragraph 11(2)).
- 8. The description of the premises must include the following information:
 - Where the premises is a building, or part of a building, whether the whole building is subject to the permit, or only part of it (with a description of the uses to which the rest of the building is put) and the nature of the building (e.g. whether it is detached, multi-level, part of a shopping centre or service station etc).
 - The nature of the area in which the premises are located (e.g. primarily residential, for business or retail use etc).
 - The name or nature of any immediate neighbours. Immediate neighbours means, in relation to premises that are in a building or on a track, those on either side of the premises; those opposite any entrance or exit to the premises; and where the premises are part of a multi-level building, those above and below the premises.
 - The nature of the street on which any entrance or exit to the premises is located. This
 information should describe whether or not the street is pedestrianised, is a main road, a cul
 de sac, a side road etc.
 - Access to the premises in particular give details of any direct access (including shared)
 that will be permitted from other types of premises with details of the nature of that other type
 of premises.
 - The current use of the premises.

- 9. Such policies and procedures should incorporate:
 - Ensuring the safety and protection of children admitted to the premises. For example
 evidence of a policy that the applicant and all persons employed on the premises have been
 subject to an appropriate Disclosure and Barring Service check which reveals no relevant
 offences or that in the absence of such checks that unaccompanied children will not be
 admitted.
 - Discourage or exclude children during school times.
 - Discourage or exclude vulnerable persons.
 - Ensure that all persons engaged in the operation of the premises are/will be suitably trained.
- 10. Applications must be accompanied by a scale plan of the premises showing:
 - The extent of the boundary or perimeter of the premises or part of the premises
 - The location of any external or internal walls
 - The position of each point of entry to and exit from the premises
 - Identify the location and use of any other areas of the premises accessible by the public which are used for the purposes of gaming or any other purpose.
 - The type and location of machines including skills with prizes machines or amusement only machines.
