LICENCES FOR SEX ESTABLISHMENTS

NEWSPAPER ADVERTISEMENT

Within seven days of applying for a licence a notice advertising the application has to be published in a local newspaper circulating within the area of the City of Newcastle upon Tyne. The responsibility for publishing is the applicant's. The City Council is empowered to prescribe the form of notice and accordingly requires applicants to follow the format set out hereunder. Applicants should note that a complete copy of the newspaper in which the advertisement has been inserted should be sent to the Licensing Authority, 7th Floor, Civic Centre, Newcastle upon Tyne, NE1 8QH.

FORM OF ADVERTISEMENT

SEX ESTABLISHMENT

OBJECTIONS

Any person who wishes to object to this application must give notice in writing of his objection to the Licensing Authority, 7th Floor, Civic Centre, Newcastle upon Tyne, NE1 8QH within 28 days of the date of application which is given above. This application can be viewed at the office of the Licensing Authority. The objector must state the general grounds of his objections. The City Council will not reveal the names of objectors without their consent.

NOTES as to the completion of Advertisement

- (1) Insert the full name of applicant in block capitals.
- (2) Insert the date upon which the application was delivered to the City Council.
- (3) Delete alternatives as appropriate.
- (4) Delete as appropriate. When the application is in respect of premises the address must be given in block capitals. In the case of a vehicle, vessel or stall, the applicant must specify using block capitals where it is used as a sex establishment.

PLEASE NOTE THAT BEFORE THE APPLICATION CAN BE CONSIDERED THE FOLLOWING ADDITIONAL DOCUMENTS WILL HAVE TO BE SUPPLIED:-

- A. A complete copy of the newspaper circulating in the Council's area in which notice of the application has been published in accordance with Paragraph 10(8) of the 3rd Schedule of the Local Government (Miscellaneous Provisions) Act 1982. Copies of the forms of notice to be used in the newspaper advertisement and for display upon premises have been prescribed by the Council and may be obtained from the Licensing Authority, 7th Floor, Civic Centre, Newcastle upon Tyne. NE1 8QH.
- B. Evidence of the due service of the Notice of Application upon the Chief Constable of Northumbria Police as required by paragraph 10(14) of the 3rd Schedule of the 1982 Act. A copy of the application including a copy of all the enclosures must be sent to the Chief Officer of Northumbria Police c/o The Licensing Coordinators, Northumbria Police, Eldon Square, Floor 1, Central Management Offices, Eldon Court, Percy Street, Newcastle upon Tyne, NE1 7JB not later than 7 days after the date of the application.
- C. Evidence by Affidavit the Notice of Application has been displayed on or near the premises as required by Paragraph 10(1) of the 3rd Schedule of the 1982 Act.
