

# COVID-19 early outbreak management



# **Armed forces and defence**

#### Who should use this information?

Leadership and management of Ministry of Defence (MoD) establishments, both as workplaces and residences, including barracks, garrisons, Royal Air Force (RAF) stations, naval bases, and all other such locations. This information provides key steps to quickly identify and contain any potential COVID-19 outbreak. If you are concerned about other possible health issues then you should follow your existing processes. This guidance should be read in conjunction with, the local outbreak plan for the affected establishment, COVID-19 Defence Advice Notes, Joint Service Publication (JSP) 950 Leaflets 7-2-2 and 7-2-6, and appropriate guidance for England and the Devolved Administrations.

### What you should do to manage a possible outbreak

# **Identify**

You may be informed of a confirmed case of COVID-19 by staff, a contractor, the Defence Public Health Unit (DPHU), your medical centre, environmental health service or your local Public Health England Health Protection Team (PHE HPT).

When you are informed of more than one confirmed case with symptoms dating within 14 days of each other, go to **step 2**.

# Report

Immediately contact your local PHE HPT for help and advice. Refer to <a href="https://www.gov.uk/health-protection-team">www.gov.uk/health-protection-team</a> for contact details.

# Respond

Your local PHE HPT will work with you, your Public Health (PH), Environmental Health (EH), medical services and other stakeholders to assess the risks and advise you of what actions to take.

Depending on the outcome, your local PHE HPT and Local Authority may establish an Outbreak Control Team to help support you to manage the situation.

### General guidelines to prevent the spread of COVID-19:

There are important actions that everyone should take at all times to help prevent the spread of COVID-19. Refer to <u>Working safely during coronavirus</u> guidance or search the title on GOV.UK. This has practical steps to take and explains how you must carry out a COVID-19 risk assessment for your organisation.

The information contained on this card is specifically in relation to an outbreak, and should not replace health and safety and infection steps you already take, or have implemented as a result of consulting the 'Working safely during coronavirus' guidance.

### Information your local PHE HPT may request from you:

#### **Details of your organisation**

- name of military unit/barracks
- location (including postcode and Local Authority)
- key contact details: name, phone number, email
- number of staff and capacity

#### **Details of the cases**

- contact details of the people affected
- when the individual(s) became unwell
- when they were last present in the setting
- nature of the roles/job undertaken by any staff affected
- known links between the individual(s) with COVID-19 (in or out of the setting)
- number of people with which the individual(s) had close contact

- nature of the environment (for example layout and nature of any buildings, accommodation, communal areas)
- details of control measures
- has there been any contact with other agencies? for example PH, EH, Local Authority, Food Standards Agency (FSA), Health and Safety Executive (HSE)

#### Types of actions you may need to put in place include:



Enhanced hygiene, hand washing and cleaning regimes, and use of personal protective equipment (PPE).



Enhanced testing and tracing.



Increased staff awareness of and adherence to preventative measures.



Increased measures to isolate potentially exposed individuals.
