### **INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF NEWCASTLE CITY COUNCIL**

#### **Issue of audit opinion on the financial statements**

In our audit report for the year ended 31 March 2018 issued on 27 July 2018 we reported that, in our opinion, the financial statements:

- gave a true and fair view of the financial position of Newcastle City Council as at 31 March 2018 and of its expenditure and income for the year then ended;
- gave a true and fair view of the financial position of the Group as at 31 March 2018 and of its expenditure and income for the year then ended; and
- had been prepared properly in accordance with the CIPFA/LASAAC Code of Practice on Local Authority Accounting in the United Kingdom 2017/18.

#### **Issue of value for money conclusion on Newcastle City Council's arrangements for securing economy, efficiency and effectiveness in the use of resources**

In our audit report for the year ended 31 March 2018 issued on 27 July 2018 we reported that, in our opinion, in all significant respects, Newcastle City Council had put in place proper arrangements to secure economy, efficiency and effectiveness in its use of resources for the year ending 31 March 2018.

#### **Certificate**

In our report dated 27 July 2018, we explained that we could not formally conclude the audit on that date until we had completed the work necessary to issue our assurance statement in respect of Newcastle City Council's Whole of Government Accounts consolidation pack and concluded our consideration of an objection raised in relation to the financial statements of the Council for the year ended 31 March 2016 concerning the use of Lender Option Borrower Option (LOBO) loans.

We have now completed this work and we are satisfied that these matters did not have a material effect on the financial statements or a significant impact on our value for money conclusion.

No matters have come to our attention since that date that would have a material impact on the financial statements on which we gave an unqualified opinion and value for money conclusion.
